

Nuclear War

Score Trend (Week of June 29–5, 2025)



This week, global nuclear tensions have escalated significantly due to recent military actions against Iran's nuclear program, particularly involving US strikes. - **[International Organizations]** Strengthen and renew international arms control agreements to limit nuclear proliferation and ensure rigorous verification and compliance mechanisms.
- **[NGO]** Increase public awareness and advocacy for nuclear disarmament and non-proliferation to foster global support for reducing nuclear risks.
- **[Industry]** Invest in technologies that improve verification and monitoring of nuclear activities to support global non-proliferation efforts.
- **[Military]** Enhance crisis communication channels with nuclear-capable states to prevent misunderstandings and reduce the risk of accidental nuclear conflict.





This week, the AI risk level remains moderate, primarily due to ongoing advancements in AI capabilities and their integration into various sectors. Concerns persist about alignment, misuse, and the concentration of power in AI development, particularly in military and governmental contexts. The potential for AI misalignment and privacy issues, as well as the challenges of regulatory oversight, are highlighted as significant risks. Despite these concerns, the risk score has slightly decreased from 3.8 to 3.7, indicating a stable yet cautious outlook on AI developments. The focus remains on ensuring AI systems are aligned with human values and preventing their misuse.

Recommended Risk Reduction Actions

- **[Government]** Implement stricter regulations and oversight on AI deployment in military and governmental contexts to prevent misuse and concentration of power.
- **[Industry]** Develop and enforce robust ethical guidelines for AI development, particularly in areas with high potential for misuse.
- **[NGO]** Advocate for transparency and accountability in AI systems, particularly in their use by governments and large corporations.
- **[Academia]** Conduct interdisciplinary research on AI alignment and safety to develop robust solutions for long-term risks.
- **[International Organizations]** Facilitate global cooperation on AI standards and regulations to prevent misuse and ensure equitable benefits.





- **[International Organizations]** Facilitate global cooperation to enhance climate adaptation strategies and provide support to vulnerable regions.
- **[Research Institutions]** Develop and promote advanced climate modeling tools to better predict and mitigate the impacts of extreme weather events.





Score Trend (Week of June 29–5, 2025)



This week, the pandemic risk level has been consistently moderate, primarily due to the emergence of new COVID-19 variants, increased outbreaks of infectious diseases such as avian flu and measles, and a growing mistrust in public health agencies. The situation escalated to a high-risk level towards the end of the week, driven by rising cases of avian flu and measles. Misinformation about vaccines and public health measures continues to exacerbate public mistrust, complicating efforts to manage these health threats. The need for improved communication strategies and enhanced surveillance of infectious diseases remains critical to addressing these challenges.

- **[Government]** Increase funding for public health communication strategies to rebuild trust and counter misinformation about vaccines and health measures.
- **[NGO]** Collaborate with communities to improve vaccine access and address hesitancy, particularly in high-risk and underserved areas.
- **[Industry]** Accelerate research and development of vaccines targeting emerging COVID-19 variants and other infectious diseases.
- **[Healthcare]** Enhance global surveillance systems for emerging infectious diseases and improve rapid response capabilities.
- **[Media]** Promote accurate, evidence-based information about vaccines and public health measures to combat misinformation.





Despite ongoing efforts to address these challenges, the rapid evolution of misinformation tactics continues to outpace current detection and mitigation strategies.

Recommended Risk Reduction Actions

- **[Government]** Implement stricter regulations and penalties for the creation and dissemination of deepfake content and other forms of digital misinformation.
- **[Industry]** Enhance AI and machine learning algorithms to better detect and flag AI-generated and manipulated content across platforms.
- **[NGO]** Increase investment in fact-checking initiatives and collaborate with independent fact-checkers to combat misinformation effectively.
- **[Education]** Develop and integrate media literacy programs into curricula to educate the public on identifying misinformation and enhance critical thinking skills.
- **[International Organizations]** Foster international cooperation to address cross-border misinformation campaigns and share best practices for mitigation.




